#### PERSONAL INFORMATION COLLECTION STATEMENT

# 1. Purpose of Collection

# 2. Disclosure of Personal Data

# 3. Access to Personal Data

You understand that pursuant to Sections 18 and 22 and Principle 6 of Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) ("**PDPO**"), you have the right to request access to and correction of your personal data held by the Land Registry.
